Directions for Commercial Use:

Agrobest 9-24-3 is designed for foliar use, but may also be applied to the soil or through irrigation. Foliar: Apply 2 to 4 quarts per acre with sufficient water for thorough coverage. Product can be applied at 7 to 14 day intervals at appropriate timings during the growing season. Spray in early morning or late afternoon. Do not apply during the "sunlight" hours when air temperature is above 85° F/30° C. Foliar fertilization is intended to supplement standard ground fertility programs and will not by itself provide all nutrients normally required by agricultural crops. Soil: Apply 2 to 8 quarts per acre.
