## Directions for Commercial Use:

Vigor-Cal-Bor-Moly is intended for foliar use. Apply 2.5 to 10 L /ha (1 to 4 L / ac) with sufficient water for thorough coverage. For best results, spray in early morning or late afternoon. Do not apply during the “sunlight” hours, when air temperature is above 30°C. Foliar fertilization is intended to supplement standard ground fertility programs and will not, by itself, provide all nutrients normally required by agricultural crops. This product must only be used for corrections of deficiencies as determined by foliar and soil testing. This product should be applied based on the advice of a government agricultural representative or a professional agricultural consultant.

## FIRST AID:

**IF IN EYES:** Hold eyelid open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor immediately for treatment advice.

**IF ON SKIN:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes

**IF SWALLOWED:** Call a poison control center or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control center or doctor. Drink several glasses of water or milk if able to swallow. Do not give anything to an unconscious or convulsing person.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.
