Directions for Commercial Use:

Root Fertilizing: Inject material in the feeder root zone area. Most feeder roots are located within the first 6-8 inches (15-20 cm) of soil. When applying as a concentrate by way of hand held soil injector, the application rate is 48 ounces (1.4 liters) per 1000 ft² (93 m²) or 3 ounces per inch trunk diameter (dbh). When applying material in diluted form, the dilution rate is 1-2 U.S. gallons (3.7-7.5 liters) of fertilizer concentrate to 100 U.S. Gallons (375 liters) of water, and the application rate is 75 U.S. gallons (280 liters) of mixed material per 1000 ft² (93 m²). In either method of application, 20% more is recommended if the canopy is fuller or larger than normal. Agro-K fertilizers are recommended for commercial use.

Foliar Fertilizing: Add 16 oz. (0.47 liter) fertilizer per 100 gallons of water. Spray on foliage of ornamental trees and shrubs. Agro-K products are compatible with most fungicides and insecticides. A compatibility check should be run before tank mixing. Agro-K fertilizer should be added to water and diluted in the tank mixture prior to adding the fungicide and/or insecticide. This product should be used in conjunction with Agro-K root fertilizers. Agro-K fertilizers are recommended for commercial use.
